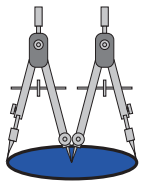

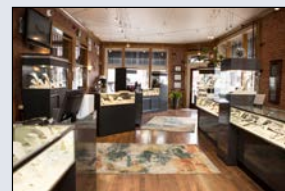

ADVOCACY UPDATE

FEDERAL

U.S. SENATOR PAT TOOMEY

Senator Pat Toomey was instrumental in crafting and passing the Tax Cuts and Jobs Act, pushing not only for a cut in the top individual rate, but also helping slash rates for corporations and repeal a key provision of the Affordable Care Act. Toomey holds seats on the Senate Budget and Finance committees and was tapped by Finance Committee Chairman Orrin G. Hatch as one of the "core four" panel members deputized to craft the legislation.



"This is the most historic reform to our tax code in over three decades," said Toomey. "In doing so, we've achieved two major accomplishments for the American people. First, we lowered the tax burden on hardworking individuals and families. The vast majority of lower and middle-income taxpayers will pay less in federal taxes. Second, we fundamentally restructured the business tax code which will enable American workers and businesses to compete globally, encourage a surge in economic growth, and create better paying jobs. This bill fundamentally shows that we believe in the capacity of the American people to restore the vibrant economic growth that we used to take for granted."

FEDERAL

U.S. SENATOR BOB CASEY

Chief among my new year priorities is to push for policies that make it easier for middle class families to make ends meet by creating jobs and raising wages. In particular, I am working to make sure that my colleagues in Congress and the Administration commit to a bipartisan solution to fixing our Nation's ailing infrastructure. Last January, I, along with a group of Senate Democrats, advocated for a plan that would make substantial investment in our national and local infrastructure and create over 15 million jobs. Just last month, I introduced an amendment during the tax debate that would have provided \$500 billion in funding for roads, bridges and local infrastructure. While this amendment was not ultimately added to the underlying bill, I will continue to call on the Administration to put forth and support a plan to rebuild our roads and bridges. As we navigate the important debates over coming months, rest assured that I will continue pushing for real investments in Pennsylvania's future.



FEDERAL

U.S. CONGRESSMAN SCOTT PERRY

In December, Congress passed a landmark tax reform package, which will deliver more jobs, fairer taxes and bigger paychecks for individuals, families and small business owners across the Country.

The plan doubles the standard deduction – from \$6,500-\$13,000 for individuals/ \$12,000-\$24,000 for married couples, expands family-focused tax benefits, and throws out many special interest loopholes. The plan also repeals the Affordable Care Act's individual mandate, and reduces the corporate tax rate to 21% beginning in January 2018. For small businesses, the plan provides a 20% deduction on taxable income up to \$315,000, which will leave the effective tax rate at no more than 29.6%.



Ultimately, the plan creates the framework to launch our economy into the modern era, something we owe to our working American families.

STATE

SENATOR RICH ALLOWAY

One way that businesses get the most out of every dollar they invest is by justifying every new and existing expense on a regular basis. Lawmakers recently took a page out of that playbook by passing a new law that implements performance-based budgeting in Pennsylvania with the goal of delivering state services more efficiently and effectively.

Too often, government leaders look to tax increases to fill budget deficits instead of searching for ways to cut spending. That approach inevitably results in a heavier tax burden that makes it harder for employers to do business in Pennsylvania.

Performance-based budgeting will add another crucial layer of accountability in state government by requiring every state agency to justify the need for every dollar they spend and clearly spell out the benefits of that spending to taxpayers. I am hopeful that this new law will ultimately help curtail the growing cost of state government and that tax burden on families and businesses.



STATE

REPRESENTATIVE DAN MOUL

During the 2017-18 legislative session, the House has approved legislation to reform the public pension systems; force public officials and employees who are convicted of public corruption crimes to forfeit their government pension; keep children safe from online predators; extend the popular and successful Children's Health Insurance Program (CHIP); protect senior citizens' prescription drug coverage; and delay implementation of the Keystone Exam as a graduation requirement. The budget work group that I assembled last summer recently unveiled a package of welfare reform bills that would require able-bodied adults without dependents to work, perform community service or participate in a work program in order to receive SNAP benefits. It limits Temporary Assistance for Needy Families (TANF) benefits beyond five years and establishes a cumulative 48-month lifetime limit, and starts a pilot program to encourage companies to hire individuals on welfare. The legislation focuses on putting people to work and ensuring benefits are directed to those truly in need.



STATE

REPRESENTATIVE WILL TALLMAN

How many pieces of legislation have been drafted so far in the 2017-18 session? While you ponder that, here are some of the issues that have made headlines.

Last June 30, the House and Senate passed a spending plan without having in place the necessary revenue to support it. I opposed the legislation on the basis of fiscal irresponsibility. The House recently passed budget reforms that would bring more accountability and transparency and rein in excessive government spending.

Pensions are one of the biggest cost drivers in the budget. Act 5 of 2017 will hopefully slow the growth of pension liabilities, shift risk away from taxpayers and ensure the state can meet its future pension obligations. While I supported the bill, we need to address the unfunded liability of state and public school employees' retirement systems.

Substance abuse remains a huge issue everywhere. Where alcohol is concerned, Act 30 of 2017 toughens DUI laws by increasing penalties and fines. Sadly, Pennsylvania's drug overdose death rate is among the worst in the country and isn't declining. We budgeted more money for opioid abuse, passed some laws on the subject and moved related bills further in the legislative process.

Finally, the answer to my trivia question about the number of pieces of legislation that have been drafted so far is 3,862 – 2,645 in the state House and 1,217 in the state Senate.

MAKING CENTS OF RETIREMENT PLANNING

As we remember to spring our clocks forward next month, thoughts of “what’s next” is a client discussion I’ve been clocking a lot of hours on lately, especially with those in the heavy throes of retirement planning.

Retirement comes with many emotions that are real, come from experiences of people close to us, and are absolutely unique to our own situation. Retirement is never a one-size-fits-all approach.

Here are some of the ways I’m working with my clients to actively think ahead for retirement peace of mind:

Consider Cash Flow

Cash flow is often the king of retirement planning: when and how to elect social security benefits, how to fill in income gaps from other retirement savings, to pay down debt or not, and running a test budget. Run a test retirement budget in the years prior to actual retirement. The retirement test run is much like any other test of a new item: practice makes perfect. Or, put another way, you never get a second chance to retire the first time.

Transition Employment

Another increasingly common practice is to gradually retire by going from full-time to part time with an employer. The talent loss of senior employees can be very challenging to replace with more youthful employees. And with a partial salary, coupled with perhaps health care benefits, this can extend a career while preserving the use of retirement funds and allowing social security benefits to accrue. I’ve seen this several times recently and this sun-setting type of retirement is an increasingly common solution.

Consolidate Assets

Consolidating assets often helps with the transition to retirement and can accomplish a number of items. First, ensure that any consolidation strategy is in your best

interest – now is not the time to be pressured into any financial decision. Always ask the “why” questions: why is something being recommended and what are the best choices for me? Please ask for all costs, fees, and commissions to be put in writing along with knowing if the advisor is required to work as a fiduciary. Informed investors should know how they are being represented so that they can understand the relationship. Second, gathering your assets under one umbrella should simplify your record keeping, help with items like required distributions, and for many couples, allows for peace of mind regarding illness or death that the surviving spouse will have a relationship with an advisor who is trusted.

Explore Your Passions

Retirement may also allow for attention to a second career. There are many stories about small businesses being launched as a retiree’s part time endeavor that blossomed into something much more. A number of my clients work part-time, volunteer, or explore their passions, all in a way to fulfill what is often recognized as the latter stages of our lives.

There is no do-over for retirement, so we must get it right the first time. With so many pieces to the retirement planning puzzle (Should you move to a smaller home? What about that attic/basement full of stuff? Estate documents in order? Have you considered pre-planning your final arrangements?) it’s important to talk it out with a skilled and trusted financial professional.
