Other CNG benefits include cleaner exhaust emissions compared to diesel. Additionally, it is an alternative fuel that is sourced domestically within the United States.

ADVOCACY UPDATE

JOYCE APPOINTED TO SMALL BUSINESS COMMITTEE

CONGRESSMAN JOHN JOYCE

The few short weeks I have spent as a new member of Congress have been nothing short of remarkable. On January 23 the House Steering Committee appointed me to the Committee on Small Business. Shortly thereafter I was named ranking member of the Subcommittee on Rural Development, Agriculture, Trade, and Entrepreneurship.



Washington has begun to eliminate burdensome regulations, cut taxes, and spur economic growth, but there is still much more to be done. The unique hurdles faced by entrepreneurs in our region are something I have seen first-hand, and this role will empower me to work on commonsense reforms that will reduce red tape and allow for job creators in Adams County to grow and expand their businesses.

As work on my new committee begins, I am looking to visit as many small businesses as possible to learn about what specific initiatives you would like me to take on in Washington.

FIRST LEGISLATION AS A STATE REPRESENTATIVE

PA REPRESENTATIVE TORREN ECKER

As I continue in my first few months as a State Representative, I have already begun to work with my colleagues to introduce legislation that will benefit constituents across Adams and Cumberland Counties and throughout the rest of the Commonwealth.



First, I am the Prime Sponsor of a piece of legislation that will formally place into law the Regulatory Review Act. This legislation will also put into law the Executive Order 1996-1, which was implemented by Governor Tom Ridge and has been used by every administration since then. My hope with this legislation is to improve the process and effectiveness in which the legislative and executive branch operates.

In addition, I have joined Representative Barry Jozwiak in co-sponsoring legislation that would help to change the Liquor Code in Pennsylvania to match the state's definition of Hard Cider at the federal level. In passing this legislation, the Commonwealth's definition would also match up with the world-wide industry standard regarding these products. My support for this has come at the request of several hard cider producers within the 193rd District who have expressed the need for this change to support our local businesses and consumers. I look forward to advocating for these two pieces of legislation as well as others as they continue to arise.

MOUL MAINTAINS POSITION ON HOUSE TOURISM COMMITTEE

When I was named chairman of the House Local Government Committee for the 2019-20 Legislative Session, I was concerned that the demands of my new responsibilities would preclude me from being reappointed to the House Tourism and Recreational Development Committee, a seat I have held since taking office in 2007. As a proud Adams County native and state representative of the legislative district that includes the Gettysburg battlefields, an abundance of fruit farms, a world renowned standard bred horse breeding facility, plenty of open space, scenic roadways and recreational trails, it is gratifying to serve on the committee that addresses laws governing travel and tourism promotion. On this committee, I successfully shepherded two major bills into law that established an on-going revenue stream for tourism promotion in Adams County, and provide protection for landowners who open their land for recreational use at no charge. I was pleased to learn recently that I have been reappointed to serve on the Tourism and Recreational Development Committee, which will permit me to continue my work in support of our tourism industry and the small businesses that provide the majority of our jobs.

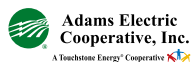

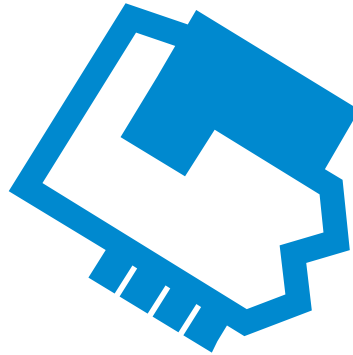
