KEVIN MALONEY, CEO

The Visiting Nurse Association of Hanover & Spring Grove (VNA)



Tell us about your business

The Visiting Nurse Association (VNA) of Hanover & Spring Grove, a community based, not-for profit organization located in Adams County, has been a cornerstone of the Hanover-Adams community since 1909.

What are your primary responsibilities?

As CEO of an independent non-profit organization, I wear many hats at the VNA. Primarily I am responsible for ensuring fluid day to day operations across both our Home Health and Hospice service lines. On any given day that could include supporting the executive team with financial, HR, or staffing issues as well as assisting management and front line staff with patient care or safety issues, professional guidance, and even IT issues. I also have a responsibility to keep our board of directors universally informed on VNA overall functions.

How do you stay engaged with trends you see in your industry?

Lots of networking! Fortunately the "health care community" is a small but very supportive group of folks in this area who are always willing to lend advice when needed. I've been very lucky to have established some really great professional relationships with work colleagues during my career. There are also some very informative Home Health and Hospice support organizations, such as the Pennsylvania Homecare Association (PHA), that do a nice job putting timely regulatory updates out to home health organizations statewide.

What business challenges keep you awake at night?

Currently staffing - specifically nurse staffing. Just like all other healthcare organizations, nurse staffing is at a critical level right now. With a shortage of nurses, it is challenging for the VNA to provide its full range of services to the community we serve. That bothers me and everyone else at the VNA, and we know there are some rough roads ahead of us. but I'm confident our VNA team will "weather the storm".

Do you have any advice for new business owners?

My advice would be to start small, stay humble, work hard and network. Some of those initial business relationships you create will end up being some of your most supportive resources as you grow. And whatever you do, be nice to people...even on your most challenging days.

What leadership advice would you offer to other business and organization leaders?

I have a quote from Simon Sinek, a popular leadership guru, framed on my office wall. I read it each morning as it really inspires me to do my best each day. It reads "The role of a leader is not to come up with all the great ideas. The role of a leader is to create an environment in which great ideas can happen."

As someone doing business in Adams County, how does the chamber help you?



ADVOCACY UPDATE

LOCAL GOVERNMENT BILL VETOED; EFFORTS TO PRESERVE PENNSYLVANIA HARDWOODS BY REP. DAN MOUL (R-ADAMS)

My legislation to make several technical changes and clarifications to the Borough Code, including enabling a municipality to be incorporated out of an existing city or township of the first or second class, passed in the General Assembly and was sent to the governor to be signed into law. However, the governor vetoed the measure. House Bill 1184 would have enabled residents in an area plagued by high taxes and limited public services to separate from the larger municipality and form one of their own.

According to the Pennsylvania Department of Agriculture, Pennsylvania leads the nation in the production and export of hardwood lumber. As chairman of the House Agriculture and Rural Affairs Committee, I am keenly interested in the preservation and responsible management of the Commonwealth's hardwood industry, which produces over \$36 billion annually in total economic impact and employs about 64,000 Pennsylvanians.

I recently traveled to Pennsylvania's northern tier to tour some of our Commonwealth's most prized hardwood forests to learn more about how this important commodity is grown, maintained and harvested. I also learned about invasive plants and weeds that can interfere with healthy tree growth; the importance of selective cutting to ensure robust and sustainable forests; and challenges such as available funding, workforce and climate issues that can have a detrimental impact on industry growth. It may surprise you to know that Pennsylvania has more forest than it did 100 years ago! That speaks well of our Commonwealth's land management and preservation efforts.



WE MUST MOVE TO SAVE OUR SMALL BUSINESSES BY REP. TORREN ECKER (R-ADAMS/CUMBERLAND)

When Gov. Tom Wolf closed nearly every business during the early days of the COVID-19 pandemic, Pennsylvania went from collecting a steady stream of revenue, including unemployment insurance payments, to draining its unemployment compensation reserves and being forced to rely on federal loans to meet its obligations to unemployed residents. Now our small businesses could be left holding the bag if the General Assembly does not act.

And we are not talking about a few bucks. Small businesses could be on the hook for the \$700 million debt in the state's Unemployment Compensation Trust Fund that is owed to federal government by November 2022.

Should the Legislature not take the lead on fixing this issue, small businesses, the lifeblood of our communities, will face huge increases in unemployment insurance premiums at a time when they are just beginning to recover from the closure while also battling record inflation. This would have a direct impact on businesses' ability to hire new employees

The Commonwealth is currently sitting on \$2 billion in mostly unrestricted American Rescue Plan Act funding, intended to give our state flexible funds to address unexpected and disastrous economic consequences of an unprecedented pandemic. This is why I have fought to preserve these rescue funds. These funds are precisely what should be used for the Unemployment Compensation Trust Fund crisis. Our small businesses have suffered long enough.

SUPPORT LOCAL FARMERS BY MARTY QUALLY, ADAMS COUNTY COMMISSIONER

Now that we have completed winter and the traditional sputtering start to spring, finally Spring is here (or at least for the next few weeks before Summer starts). To me the beginning of Spring is when the Adam's County Farmers Market opens for the season. This year it is a little early with the season starting on April 23rd. The market is located behind the Gettysburg bus station and runs from 8am until 1 p.m. every Saturday between April 23rd and October. Of course, there are countless roadside stands and other large markets in the county, which I encourage you to discover, but the Adams County Farmers Market will always have a special place in my heart. What is special to me besides getting fresh produce,



is the support shopping at a local market brings to our community. The Adams County Farmers Market isn't just about fresh local products. They serve as an incubator for small businesses, they have programs to provide food at affordable rates for seniors and low income families and they provide a sense of community. Take the time to buy local. Not only is it delicious, but you will be doing your part to keep Adams County a special place, one bite at a time.



RETIREMENT PLANS: ARE YOUR EMPLOYEES LOOKING ELSEWHERE?"

Employers of all kinds are facing new obstacles today in this pandemic-impacted economy. In what they call the "Great Resignation of 2021", workers are leaving their jobs in massive numbers. Subsequently, businesses are finding it difficult to attract and retain new employees.

What we do know is that employees will put forth their best efforts and go above and beyond when they feel that their employer values them and that they are appreciated in their role. A retirement plan is one of the most common methods of showing that appreciation.

According to a survey by Principal Financial Group, of those surveyed, 77% said the COVID-19 pandemic has driven them to focus more on saving for retirement. Also, when evaluating new job opportunities, 91% thought an employee match was the most important retirement plan feature, 80% said eligibility, 74% said vesting requirements for company match, 73% said investment options on offer and 70% withdrawal options at job change or retirement.

So, with that in mind here are a few things to consider when starting or updating your retirement plan benefits:

- · Increase employer matching contributions into the 401(k).
 - · Increasing your employer match by 1-2% can greatly increase your chances of beating out the competition.
- · Add profit sharing to your 401(k).

- This not only helps with retirement savings for your employees but can increase productivity since it is typically tied to company profits.
- Expand eligibility requirements.
 - · Consider immediate eligibility instead of requiring employees to wait the normal 1 year of service before being eligible to participate.

A final recommendation is to start by surveying existing employees and even prospective employees to uncover what benefits are most valued. Using that data, you as an employer, can start to make informed decisions.

So, if you don't have a retirement package in place for employees, consider starting one because most likely your competition already has.
