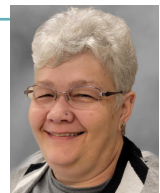

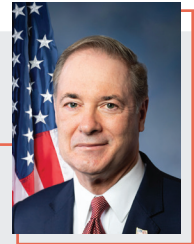

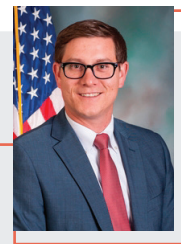

## MODEL FOR FAILURE

A business or an individual relationship with a financial institution is important to their financial wellbeing and futures. Thus, the financial condition of one's bank to deliver services without failure is essential for seamless business and personal transactions. After observing the collapse of the second largest bank in U.S. history, Silicon Valley Bank, gave me cause to know why this happened and should we be concerned.

Silicon Valley Bank (SVB) allowed themselves to operate without a risk manager for nearly a year during a critical stage of their operation. Their Board of Directors had only one board member with banking experience. SVB lacked U.S. Treasury oversight of operational decisions such as making large political donations when lacking the financial strength to do so. Also of concern, SVB adopted ESG guidance to make their financial decisions rather than using sound monetary principles. The United State cannot build a strong banking industry following the politically motivated practices of the SVB or others doing the same. The SVB model of operation opens the way to more bail outs funded by taxpayer dollars and unnecessarily disrupting our economy. Perhaps it's time to examine how your bank operates. Your interest could be at stake.

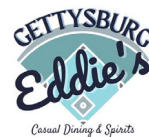
