**Eligibility**

**Individuals who own and operate or bear principle responsibility for operating a for-profit business with 50 or fewer full-time or full-time equivalent employees may be nominated. Partners who jointly own and operate a small business may be nominated as a team. The nominee's business must be a member of the Gettysburg Adams Chamber of Commerce and must be located within Adams County.**

**Award Criteria**

**The award will be given to the nominee that in the opinion of the chamber's Awards Committee is most deserving of recognition. Nominations will be evaluated according to the following criteria contributing to the Gettysburg-Adams County area business climate:**

- 1. Business History and Growth: A substantiated history as an established business, focusing upon measurements of growth in the business' target market. A benchmark to judge the impact of the business on the job market.**
- 2. Business Innovation: Evidence of the creativity and imagination of the nominee contributing to the success of the business.**
- 3. Business Challenges: Examples of challenges faced in the nominee's business and the methods used to address them.**
- 4. Community Involvement: Evidence of contribution by nominee to aid community-oriented projects through the commitment of both personal time and other resources.**

**Award Selection**

**The chamber's Awards Committee will review and evaluate all nominations based upon the award criteria provided. The committee will base their selection on the written**

narrative and supporting evidence. All nominations will be treated as confidential. Nominations submitted are not required to provide or to reveal proprietary information.
