Gettysburg National Military Park celebrated the reopening of Little Round Top with a ceremonial ribbon cutting. The Little Round Top area of the Gettysburg battlefield, which saw extensive

fighting on the afternoon of July 2, 1863, was closed to the public for almost two years for rehabilitation efforts to improve parking areas, accessibility and safety, and address erosion and vegetation issues. Funding for the project represents a mix of federal funds and generous donations. The total cost of the project was \$12.9 million, of which \$5.2 million came from donations from the **Gettysburg Foundation**, National Park Foundation, and the American Battlefield Trust.

For those that haven't heard of Servants before, they are a nonprofit organization that provides home repairs for low-income seniors and people with disabilities, at no cost. Joe Sylo loves his job at Servants, where he is the Director of Development, and oversees the planning and execution of a fundraising program that gives the organization the ability to serve our community.

"My favorite part of working at Servants is the people. I'm always inspired by their kindness, generosity, and love for the people," Sylo said. "I have the mindset of instead of driving into 'work' every day, I'm driving in to serve... to make a difference for someone else."

When working with a homeowner, every repair the nonprofit does is completely free. From the staff and materials to the tools and trucks, everything needed to complete the job is at no cost to the home owner thanks to generous donors and support.

Next year, the nonprofit will celebrate their 25th anniversary and they have already hit a milestone of completing 1,500 home repairs. They have been serving Adams County for the past three years.

In that time they have made lasting connections with generous volunteers, churches, and business leaders that have helped them along the way to provide the best support for the community.

"We partner with organizations like the Adams County Community Foundation and the Adams County Office of Aging," explained Sylo. "These partnerships allow us to stay connected to the needs and trends in the community."

Relying on fundraising, support, and volunteers to have continued success at Servants, Sylo fully believes in everyone helping where they can.

"I always say, 'the need is great, and the resources are few'. If you've donated to a local nonprofit- thank you," he said. "If you haven't, please find a cause with a meaning for you and support them to the best of your ability."

ADVOCACY UPDATES

IMPROVING EDUCATION, BOTTOM TO TOP, IN PA REPRESENTATIVE TORREN ECKER



Pennsylvania took a big step forward in helping students prepare for the future by improving career and technical education options. The Education Code, which is a driver in how Pennsylvania students learn, took several steps to prepare them for the future.

It prescribes that career and technical education programs align with industry credentials and occupations that earn a family-sustaining wage, including programs that lead to careers in education. It also dictates to strengthen high school curricula by creating rigorous college and career preparation programs, including advanced placement and dual credit courses.

There are several industries facing workforce shortages and we aimed to address that now and in the long term. To get more students into these industries, such as education and nursing, the new Grow Pennsylvania Scholarship Grant Program will soon be implemented. The program will award \$5,000 grants to Pennsylvania students taking courses for training to fill high-demand jobs. In exchange, the students must agree to stay and work in the state for 12 months for every year they receive a grant.

Education is the key to prosperity, not only for individuals, but for our community at large. The investments and decisions we make today will come back multiplied in the future.

2024-25 STATE BUDGET UPDATE REPRESENTATIVE DAN MOUL



Nearly two weeks past the June 30 deadline, the General Assembly approved, and the governor signed into law, a state budget for the 2024-25 fiscal year. I voted “no” on this budget because the plan will spend \$47.6 billion, a \$2.7 billion, or 6%, increase over the prior fiscal year. It is approximately \$740 million less than what Gov. Josh Shapiro sought when he unveiled his budget proposal in February. While this budget provides significant funding increases for our schools, agriculture, and other important initiatives, it will spend about \$3.3 billion more than the Commonwealth is anticipated to collect in revenue over the coming fiscal year. This will require the use of reserve funds, which is not a sound long-term strategy. In fact, it is unsustainable. To learn more about the state budget, visit PAHouseGOP.com/budget2024.

WHY YOU SHOULDN'T LEAVE LAPTOPS IN HOT CARS

Summer is in full swing in southern Pennsylvania. Sunshine, pool parties, ice cream – damaged electronics? We know the dangers of leaving children and pets in cars on a hot day. Laptop batteries are especially vulnerable to heat damage. High temperatures reduce their lifespan and performance. You may find your laptop will no longer hold a charge. In severe cases, the battery may also swell or leak.

Another piece at risk is your laptop screen. LCDs are a common type of screen used in most laptops and can suffer from heat damage. Long exposure can result in discoloration, pixel damage, or complete loss of the screen.

High temperatures can also compromise the data stored on your laptop. A laptop's fan is vital in

helping to keep the inside of your laptop cool. Without it running the hard drive can become corrupt and fail. If you haven't backed up your data - say goodbye to your important files! Preventing heat damage is crucial, but so are regular data backups.

Moreover, leaving a laptop in plain sight can attract thieves. Even if the laptop is hidden, cars are often targeted for valuable electronics, increasing the risk of theft and exposure of your sensitive data.

To keep your laptop cool and safe, always take it with you when leaving your vehicle. If you have to leave it for a short period, make sure it's completely shut down and use an insulated laptop bag or sleeve. An insulated bag can help keep the internal temperature of your laptop stable.

Parking in the shade and using a sunshade for your windshield can help reduce the inside temperature. Not only will it help your laptop, but it can also prevent UV rays from damaging your vehicle's interior.

Finally, you should regularly back up your data to prevent potential data loss. Regular backups ensure that a copy of your important information is available even if the original is compromised.

Protecting your laptop from excessive heat ensures its longevity and keeps it reliable. By being mindful you can keep your laptop cool and secure!

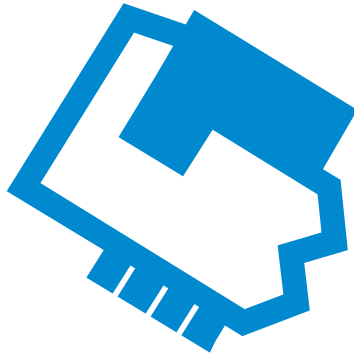
